

Sale conditions Bubus Snakery

Version: 18th August 2020

- With the purchase or reservation of one or more animals, the buyer expressly agrees to all of the points listed below and confirms that he is aware of the parameters for species-appropriate keeping as well as the necessary preparations for moving in the snake(s).
- My breeding is carried out exclusively as part of a private hobby breeding and not for commercial purposes. The selling prices of the animals are an allowance for expenses and only cover part of my expenses. As a private seller, I exclude any guarantee or warranty. I am not responsible for any subsequent illness, death or loss of an animal.
In addition, to protect my stock, a return or an exchange is not possible after animals moved out!
- Animals are only given to adults.
I reserve the right to check if you are of legal age by using your identity card, before submitting or making a reservation. This applies in particular in the case of animal dispatch or other takeover by third parties.
- Should a takeover of animals by a third party take place, the handover is documented in writing in a handover protocol.
- No animal will get sold as a gift, unless the person receiving the gift knows about it and is present when it is picked up!
- All animals are apparently healthy when they are handed over and all information is given to the best of my knowledge and belief.
- Juveniles are only handed over as soon as they are eating frozen/thawed well (at least 5-6 times in a row) and also shed without any problems.
If, in rare individual cases and at the express request of the buyer, animals that are not eating well, are sold, the buyer's written consent is required.
- The sexes are determined to the best of my knowledge and belief, but for anatomical reasons I cannot guarantee the correctness of females if they never laid eggs before!

Reservation and handover / shipping:

- Reservations are only possible with payment of a reservation fee of 50% of the purchase price (bank transfer, PayPal or cash).
Any kind of transfer fee has to be paid by the buyer.
The reservation fee will be deducted in full from the purchase amount.
Unless otherwise agreed, a period of 4 working days is granted for receipt of payment.
After the deadline has passed, I reserve the right to make an intermediate sale.
- The animals remain my property until they have been paid for in full. Before handover or shipping, the outstanding payment is due in full in advance. Shipping is only possible with prepayment of the full purchase price plus shipping and packaging costs.

If the buyer does not comply with the collection or receipt by shipping within three weeks (unless otherwise agreed), the reservation expires and the paid reservation fee will not be refunded.

It is not possible to offset the paid reservation fees with some reserved animals (if not all reserved animals will get purchased). Each reservation including the paid reservation fee applies to each animal separately!

- Of course, if a reserved animal dies or can no longer be handed over for other good reasons for my part, the reservation fee, paid for the respective animal, will be fully refunded.
- Shipping by an authorized animal transport company might be possible at the buyer's expense. I take care of the organization and selection of the transport company.
However, no animals are sent below + 10°C (at night) and above + 30°C (during the day).

If shipping is possible depends to the buyers country, please feel free to ask for options.

Shipping is entirely at the buyer's risk. I am not responsible for any damage or loss.

If additional costs arise, for example because the recipient was not found and a new delivery attempt was made, these will be charged in full to the buyer.

- Handovers of reserved animals are possible at reptiles shows that I will join.
